N.Y. Republican suspends campaign

ALBANY | Fighting plunging support, Republican Dierdre Scozzafava abruptly suspended her campaign Saturday in a special election for a U.S. House seat that has exposed a rift among national factions of the party.

Campaign spokesman Matt Burns said Scozzafava is essentially withdrawing from the race, although her name will remain on Tuesday's ballot. She thinks stepping aside is best for the party, he said.

"It is increasingly clear that pressure is mounting on many of my supporters to shift their support," Scozzafava said in a written statement. "Consequently, I hereby

release those individuals who have endorsed and supported my campaign to transfer their support as they see fit."

The announcement comes after a Siena College poll found she was in third place with 20 percent of the vote in the heavily Republican upstate New York district that has been safe ground for the party for more than 100 years. Conservative Party nominee Doug Hoffman and Democratic nominee Bill Owens were too close to call with 35 percent and 36 percent, respectively.

The race has pitted conservative and moderate wings of the Republican Party in a battle of ideology both nationally and statewide. Hoffman and his

backers say Scozzafava is too liberal to represent the GOP, specifically noting her support of abortion rights and same-sex marriage.

In the short run, the development consolidates Republican voters behind the conservative candidate and improves the party's chances of retaining the seat in the 23rd Congressional District, which encompasses all or parts of 11 counties in rural northern and central New York.

Longer term, Democrats will cast this as a troubling sign for the GOP because it exemplifies that divide in the party between moderates and conservatives, with those further to the right, including the "Tea Party" movement, now getting the upper hand.

Arrest made in fire at chapel for 9/11 victims

NEW YORK | A man was arrested Saturday on suspicion of setting a small fire at the temporary home for the remains of thousands of World Trade Center victims, police said.

Police announced the arrest nearly 12 hours after the fire, which was set following a break-in. Charges against the 26-year-old were pending, police said.

The smoldering flames in a section of the facility's chapel on Manhattan's East Side were quickly extinguished.

Firefighters got a call at about 9 a.m. to respond to Memorial Park, a weather-proof tent on Manhattan's East Side where the city is storing the remains of 9/11 victims who have yet to be identified.

The fire damaged a wooden bench, while mementos — pictures, notes, flowers — honoring the dead disappeared.

"Anyone who would set

fire to the inviolable Memorial Park chapel is craven and contemptible," Mayor Michael Bloomberg said in a statement.

Fire marshals and police were investigating.

Nazli Parvizi, the mayor's community affairs commissioner, sent 9/11 families an e-mail informing them of the incident. Sally Regenhard, whose son perished at the World Trade Center, forwarded the statement to The Associated Press.

Parvizi told the families that about an hour before the fire started, a break-in was discovered in the chapel. Memorial Park is near the city medical examiner's office, which created special photo IDs to be used by families to enter the site.

Authorities were unsure whether the mementos had been stolen or burned, "but little remains inside the chapel," said Parvizi, adding that the structure showed some smoke damage.

N.Y.'s Fairbank Farms ground beef recalled

ASHVILLE | A New York meat company has recalled almost 546,000 pounds of ground beef because of links to illnesses from E. coli bacteria in Connecticut, Maine and Massachusetts.

The U.S. Department of Agriculture said Saturday the meat, sold by Fairbank Farms in Ashville, was linked to cases of the food-borne illness in the three New England states. The agency said retail stores, including Trader Joe's, Price

Chopper, Lancaster, Wild Harvest, Shaw's, BJ's, Ford Brothers, and Giant, sold the ground beef. Each package carried the number "EST. 492" inside the USDA inspection mark or on the nutrition label.

In addition, ground beef packaged under the Fairbank Farms name was distributed to stores in Maryland, Massachusetts, North Carolina, New Jersey, New York, Pennsylvania, and Virginia for further processing.
