# Massa supports Obama's stimulus

WASHINGTON, D.C. | Despite his reservations, U.S. Rep. Eric Massa, D-Corning, said he supports President Barack Obama's stimulus package.

Massa said

ning he hasn't

package, but agreed that the federal government must take bold action to kick-start the nation's economy.

"The sad reality is that if we do not act we will be looking at double-digit unemploy-ment very soon," Massa said. "Every economic expert that's testified before Congress -Republican, Democrat, conservative, progressive - agreed we must act decisively."

Massa said the House could vote as early as today on a stimulus package. He said the package contains money to aid local school districts and for projects such as the completion of interstates 86 and 99.

He did express regret, however, that the bulk of the stimulus package was being financed through deficit spending. Prior to being elected,

# Man with 15 pounds of pot gets probation

**ELMIRA** | An Elmira man who pleaded guilty to possessing 15 pounds of marijuana was sentenced Monday to alternating weekends in jail and five years probation.

James A. Shope, 35, will spend every other weekend in jail for four months. Also, he was

ordered to pay a \$5,000 fine. Chemung County Judge Peter Buckley imposed the light sentence because he said Shope has been performing community service since his arrest.

Shope, who owns a painting and drywall company, has been painting the John Jones Museum in Elmira, among other charitable projects.

Police found 15 pounds of marijuana after pulling over Shope on March 18, 2008. The drugs had an estimated street value of \$130,000, police said.

The maximum sentence Shope faced was 5.5 years in state prison.

The District Attorney's Office told WETM TV Channel 18 it was disappointed with the sentence because it sent

the wrong message.
