Mychalejko denied any connection with the group arrested two weeks ago.

"He has not returned our calls, he refuses to talk to us," Mychalejko said. "Now, since he has stated he is willing to talk to his constituents any time, that seems a little disingenuous."

Mychalejko and other protesters Thursday claimed they are local residents and not political operatives from other areas.

Protesters were told Thursday by village Police Chief David Rouse they could not assemble in front of Kuhl's district office or stage a rally because they had not applied for a parade permit.

Meghan Tisinger, director of communications for Kuhl, said the protesters should call the district office for an available appointment.

"They need to go through the same procedure as everyone else," Tisin ger said.

Mychalejko said Kuhl should explain his support of the war to the voters.

"If he's willing to send the sons and daughters of the people here into a meat grinder, he should be willing to answer a few questions," Michalejko said.

The girls said they didn't know how far along the dark, winding road the SUV followed them. But Sayasith's car was traveling at more than 70 miles an hour when it left the 30-mph road at a bend, hurtled down a steep embankment and plowed into trees.

Sayasith was killed along with fellow Churchville-Chili High School junior Kaitlin Palmer, 17. Another passenger, Theodore Piendel, 16, died of his injuries eight days later.

confrontation around 10 p.m. on May 27 may have been triggered when another car drove down a nearby private driveway a short time earlier, friends of the victims said. The family at that residence had been irritated by pranksters ringing the doorbell and then running off before someone

answered, they said.

Sayasith "didn't want any confrontation and that is why he didn't get out of the car. They wanted to get out of that situation," his aunt, Julie Pathammavong, said Thursday's Rochester Democrat and Chronicle.

"This wasn't a story of teenagers driving irresponsible and speeding. They were being chased, and the people who were chasing them need to come forward and say something."

District Attorney Mike Green said the men who confronted the teens were interviewed but the case will not be forwarded to a grand jury because "there's not enough to show a cause-and-effect relation ship."

Both the Monroe County prosecutor's office and the sheriff's department declined to say what led to the confrontation.


