walk-right-in-sit-right-down atmosphere at the Buell Street location.

Kuhl said then it was done to protect staff which, given the circumstances, was understandable. But it sent a message that the open-door policy was no more.

Then came the format change to Kuhl's town hall meetings that dated back to his early days as a state representative and carried through three of his four years as a House member. That's when he annually held 30-minute meetings in all the towns and villages in the district to get ideas and hear the concerns of those he represented. Back then, anyone could come and talk and shake the hand of the man they put in office.

But that changed this year. Instead of Kuhl simply standing around and openly chatting with folks, he held meetings with individuals or small groups. Private matters could be better discussed, Kuhl explained.

Many others said issues that Kuhl didn't want to talk about or, more importantly, people he didn't want to see, could be filtered out.

Regardless of how Kuhl explained it, the format change was a buffer. It seemed he became uncomfortably aware that he had become a target of those who disagreed with his voting record, his ties to the Bush administration or his views on health care and immigration. And, he wanted no part of it, at least not face-to-face.

Now, he wants similar protection when he debates Massa. Kuhl wants to make sure he's on a neutral field, or no field at all. He has that option and has exercised it.

Two years ago, Kuhl retained his seat by a very slim margin over Massa, a first-timer to the political realm. Could be Kuhl's thinking that circling the wagons and limiting risk is the best strategy to stay in office.

# Newman dies at 83

WESTPORT, CONN. | Paul Newman never much cared for what he once called the "rubbish" of Hollywood, choosing to live in a quiet community on the opposite corner of the U.S. map, staying with his wife of many years and - long after he became bored with acting - pursu-


ing his dual passions of

philanthropy and race cars. And yet despite enormous success in both endeavors and a vile distaste for celebrity, the Oscar-winning actor never lost the aura of a towering Hollywood movie star, turning in roles later in life that carried all the blueeyed, heartthrob cool of his anti-hero performances in "Hud," "Cool Hand Luke" and "Butch Cassidy and the Sundance Kid."

The 10-time Academy Award nominee died Friday at age 83, surrounded by family and close friends at his Westport farmhouse following a long battle with cancer, publicist Jeff Sanderson said Saturday.

In May, Newman dropped plans to direct a fall production of "Of Mice and Men" at Connecticut's Westport Country Playhouse, citing unspecified health issues. The following month, a friend disclosed that he was being treated for cancer and Marth a Stewart, also a friend, posted photos on her Web site of Newman looking gaunt at a charity luncheon.

But true to his fiercely private nature, Newman remained cagey about his condition, reacting to reports that he had lung cancer with a statement saying only that he was

"doing nicely."

As an actor, Newman got his start in theater and on television during the 1950s, and went on to become a legend held in awe by his peers. He won one Oscar and took home two honorary ones, and had major roles in more than 50 motion pictures, including "Exodus," "Butch Cassidy," "The Verdict," "The Sting" and "Absence of Malice."

Newman worked with some of the greatest directors of the past half centu-

ry, from Alfred Hitchcock and John Huston to Robert Altman, Martin Scorsese and the Coen brothers. His co-stars included Elizabeth Taylor, Lauren Bacall, Tom Cruise, Tom Hanks and, most famously, Robert Redford, his sidekick in "Butch Cassidy" and "The Sting.'

"There is a point where feelings go beyond words," Redford said Saturday. "I have lost a real friend. My life - and this country - is better for his being in it."
